

B-K Electric, Inc.'s FCC Licensing and License Administration Costs

Effective April 1, 2010

1. **B-K Electric, Inc.'s fee for initial new license preparation, frequency coordinator requests and monitoring, application filing, administration, and construction notice filing:** \$260.00 per call sign, plus coordination and FCC filing fees.
2. **B-K Electric, Inc.'s fees for modification or renewal of any existing license that DOES NOT require frequency coordination, such as adding narrowband emission designators:**
 - a. Adding narrowband or modifying emission designators to include narrowband and digital: \$75.00 per call sign, plus FCC filing fees.
 - b. Other modifications or filings requiring an FCC application: \$75.00/hour and \$75.00 minimum, plus FCC filing fees.
3. **Each NEW FCC Part 90 frequency (or frequency pair) must be approved for filing by an authorized FCC *Frequency Coordinator*. This applies to new applications, modification of existing licenses involving additional transmitter power or antenna height, or to changes in transmitter location or operating area. Coordination DOES NOT apply to applications involving only administrative changes or adding narrowband or most other new emissions designators. B-K has a close working relationship and volume pricing with several frequency coordinators and can offer the following special pricing:**
 - a. VHF Simplex; one new single frequency, including base and mobile applications: \$280.00
 - b. VHF Duplex; one new frequency pair, including repeater, fixed control station and mobiles for both simplex and duplex operations: \$560.00
 - c. UHF Duplex; one new frequency pair, including repeater, fixed control station and mobiles for both simplex and duplex operations: \$280.00
 - d. If required, there will be an additional fee for each cross-service frequency coordination: \$100.00 each.
 - e. Public Safety or Governmental Agencies authorized to purchase from us under any GSA contract pricing will receive a 20% discount on the above coordination fees.
 - f. Special circumstances may require additional coordination fees that B-K Electric, Inc. will pass along at its cost.

New, Renewal or Renewal/Modification

- Payment/Fee Type Code: PAZR - **\$85.00 Fee (Per Call Sign)**

PART 90 & PART 95 FEE EXEMPTIONS:

Eligibles filing as Governmental Entities are exempt from fees.

There is no fee for applications filed for

- purposes of Amendment to a Pending Application (unless adding call signs/lease ids, adding waivers, or changing Exemption for the Fee(s) to 'No'),
- Administrative Update to a License/Lease/Sublease,
- a Request for Withdrawal of a Pending Application,
- Request to Cancel a License/Lease/Sublease,
- Notification of Consummation (unless requesting a Rule Waiver for § 1.948[d]),
- Request for Extension of Time for Consummation (unless requesting a Rule Waiver for § 1.948[d]),
- Spectrum Manager Lease Notifications (except for purpose of Modification),
- Private Commons Arrangements,
- **Notification of Construction/Coverage Requirements**, and
- Registered Locations for the Intelligent Transportation Service and 3650 – 3700 MHz Band.

PART 97 (AMATEUR) FEE EXEMPTIONS:

There is no fee required for applications filed in the Amateur Radio Service other than an application that requests an Amateur Station Vanity call sign (initial or change) or an application to Renew an amateur station vanity station call sign. [Payment/Fee Type Code: WAVR - \$12.30 Fee (Per Vanity Call Sign)]
